Scholarship Guidelines and Highlights:

- Grants will range from \$50 up to \$500 per person or family
- Grant applications will be available on March 1st through the Hurdling Handicaps office.
- The grants will go towards giving Michigan based retreat attendees first priority and supporting a family or individual attending a Joni and Friends Family Retreat this year.
- Hurdling Handicaps will consider all applicants but will give first priority to families residing in Michigan and/or are first time scholarship applicants.
- The grant recipient(s) must meet the criteria set by Joni and Friends

- The grant application must include a family photo
- Grant applicants must agree to allow their names and family photos to be used on the Hurdling Handicaps Speaking Ministries website, the Newsletter or other promotional publications.
- A recommendation letter from your pastor must be included with the grant application.
- Grant applicants cannot be accepted from a family member of the Board of Advisors or staff of HHSM
- The grant check will be payable and sent directly to Joni and Friends.
- Scholarship recipients will be asked to submit a short testimonial including pictures of their retreat experience.
- All grant applications must be postmarked by May 15.

Tax deductible gifts can be made to the Bill and Sue Patton Scholarship Fund by making your check payable to Hurdling Handicaps and will be deposited directly into the scholarship fund account.
